FIRE FIGHTER
STATE AUTHORIZATION INFORMATION

REQUIREMENT: Colleges offering Fire Fighter Certification are required to provide general and direct disclosures to each student regarding the reciprocity of the program against other states.

State Authorization Professional Licensure\Certification\Credentialing Requirements:

Effective July 1, 2020 the U.S. Department of Education requires colleges to provide general and direct disclosures to students prior to making a financial obligation for all professional licensure and certification program:
Refer to the SA Requirements tab for specific details on this new regulation.

Fire Fighter Certification/Degree Information:

Fire Fighter certification requirements vary by state and other individual factors; credentials, training, job experience, criminal history or military service.

Student applications are reviewed on a case-by-case basis. There are no standardized requirements across all 50 states for the Fire Fighter certification.

Most fire departments require applicants to be a minimum of 18 years old, have a current driver's license and a high school diploma or equivalent. Potential Fire Fighters must pass drug tests and a physical examination.

Many Fire Fighters must have emergency medical technician, or EMT, certification, in addition to a firefighter course. Sometimes certification is required for hiring, while other departments include it in training for new hires.

Yet others expect firefighters to acquire certification on their own during the first year.

Many people think of taking Fire Fighter exams in other states, thinking it may be easier to get hired in another state. Chances are it is as tough (if not tougher) than where you currently live.

Fire Fighter Certification/Degree State Contacts:

This workbook contains the individual state Fire Fighter program point(s) of contact, which include name, phone number, e-mail, and physical address.

Other things to consider when getting Firefighter certification/degree:

- Is your EMT certificate (or paramedic license) transferable? Many states (meaning state EMS agencies) do not accept EMT certificates or paramedic licenses from other states.
- If you truly are interested in working out-of-state, pay the extra money to get your National Registry EMT certificate or National Registry Paramedic certificate.
- Some states have reciprocity and some do not. California for example does not currently accept Firefighter I certificates from any other states.
- To better prepare, you can either contact fire departments you are planning on applying, to or call the state fire marshal's office in the state you desire to work in.

State Authorization Professional Licensure Information:
34 CFR 668.43(c) Direct Disclosures

1. Prior to enrollment, students must be notified in writing (direct disclosure) if the program does not meet OR the institution has not made a determination whether the program meets education requirements for licensure and/or certification in the state where the student is located.
2. The regulations state "regarding the timing of these disclosures, the U. S. Department of Education (DOE) expects that the institution will provide this disclosure before a student enrolls into a program or in the event that an institution does not provide an enrollment agreement, before the student makes a financial commitment to the institution
3. If the student is enrolled in a program and the institution makes a determination that the program does not meet educational requirements in the state where the student is located, the institution has 14 calendar days to notify the student in writing.

NOTE: Be sure to document that that any required direct notifications (pre enrollment and/or address change) were sent. An easy way to do this is to ensure that a copy of the letter or email is kept within the student's academic record.

Additional Information: At minimum, applicants must be 18 years of age or older, must hold the State of Alabama's valid driver's license, must have successfully completed the Candidate Physical Agility Test (CPAT), must hold the State of Alabama's EMS certification at the EMT-Basic level or above, and must pass firefighter written exam with a passing score of 70%. Firefighter requirements in Alabama vary according to local jurisdictions, as opposed to some other occupations where each state sets educational and experience expectations.

An applicant must pass an aptitude test, and the strength and agility test. Next comes oral and panel interviews and a criminal background check.

Additional Information: California requirements vary. For example, if you are interested in becoming Fire Fighter I, which is a seasonal and temporary classification, then you must be at least 18 years of age at the time of appointment. However, if you seek a permanent position with the Burbank Fire Department, then you must be at least 21 years of age at the time of appointment. Since the requirements vary so much, the following should only serve as a general guideline on minimum requirements to become a firefighter in California. Fulfill minimum age requirement, be a US citizen, have a high school diploma or GED, hold a valid state of California driver's license, be certified as Emergency Medical Technician (EMT), and have valid Candidate Physical Agility Test (CPAT). The application process itself will usually take a few months to complete.

The state of California lists firefighting jobs amongst Fire Protection Careers. Some of the careers offered under this classification are Fire Fighter I, Fire Fighter & Fire Firefighter (Paramedic), Fire Apparatus Engineer & Fire Apparatus Engineer (Paramedic), and Heavy Fire Equipment Operator (HFEO). Each of these positions will have its own set of hiring requirements.

Additional Information: Minimum requirements in Georgia include being at least 18 years of age, holding a high school diploma or GED, being in good physical condition, successfully completing the Georgia Firefighter Standards and Training Council's physical agility test, and holding a valid Georgia driver's license. After these requirements are met you will take a written exam, a polygraph test, and physical and a drug screening, and undergo a criminal background check. Upon completion of the Basic Firefighter Training Course (BFTC), you will have the opportunity to take the written portion of the GFSTC-mandated NPQ I Firefighter test. If you pass, you will become Georgia state certified firefighter.

Additional Information: Minimum Requirements to Become a Firefighter in Hawaii: Meet the residency requirements and has to be a US citizen, be at least 18 at the time of his/her application, have a clean legal track record, have mental and physical health, and possess a valid driver's license. Once these requirements are met, a candidate has to appear for a written aptitude exam that tests the individual's reasoning skills and problem solving abilities. If the individual passes this test, he/she is called for a physical agility exam, which requires the candidate to perform various exercises and tasks. If the person's performance on the physical test is satisfactory, he/she is called for a panel interview that assesses the candidate's potential. He/she also has to go through background screening, psychological exam, medical test, and a polygraph test.

Additional Information: Minimum Requirements: Applicants must be at least 20 years of age at the time of filing of application and 21 years of age at appointment. Applicants older than 34 years may not be considered for employment. Applicants must have a high school diploma or GED. Successful completion of the Candidate Physical Ability Test (CPAT) and the ability to climb ladders. All applicants must have correctable vision to 20/20 in each eye. All applicants must be of good moral character. They must agree to be fingerprinted and during thorough background investigation must not be found convicted of a felony or certain misdemeanors. He/She must live in the county where he/she works as a firefighter or within a certain mile radius of a landmark (as specified by your employer). All applicants must possess an Illinois Emergency Medical Technician Paramedic (EMT-P) license at the time of application. They must also meet the requirements of the Municipal Fire and Police Civil Service Law, after the employment offer, and before beginning the job, all firefighters will be required to pass a physical exam, applicants ought to possess any of the following: "high school diploma, high school equivalency certificate, high school transcript, affidavit from the issuing high school, associate's or bachelor's degree, or college transcript, any one of which must indicate that graduation has occurred or a degree awarded. A certification of completion shall not be sufficient to substitute for a diploma or equivalency certificate", candidates need to have a valid driver's license, and should not be less than 18 years old. If not, then the equivalent GED certificate is acceptable too, no criminal record whatsoever. This goes for Maine as well as every other state, clear the written evaluation, high score on the Candidate Physical Ability Test (CPAT). Different fire departments in Maine may have different CPAT cutoffs. So, aim to score as high as possible on this exam, many fire departments in Maine also make it mandatory for their fire service personnel to acquire some basic medical certifications like EMT (Emergency Medical Technician) and CPR (Cardiopulmonary Resuscitation).

Additional Information: Minimum Requirements: Even though the exact requirements vary according to jurisdiction, the following general requirements are usually applicable. Be at least 18 years of age, have a valid driver's license, have a high school diploma or a GED/HSED, have a State of Wisconsin Firefighter I or equivalent, and be a nationally registered EMT-Basic. Some jurisdictions might also require an Associate's Degree in Fire Protection or Fire Science, along with certifications or licenses. In addition to that, several cities in the state require candidates to be citizens of the US as well and have a Hazmat Operations level certification. To make sure you have fulfilled all the relevant requirements, you are advised to check with the local city fire department you intend to apply. Some cities also have a residency requirement – for instance, Ashland firefighters are required to live within 15 miles from the limits of the city of Ashland.

Additional Information: Minimum Requirements: Must be at least 18 years old, must have cleared high school at least, must be a valid Puerto Rico driving license holder, must not have a criminal record of any kind, whether in Puerto Rico or any mainland American territories, must qualify the written test designed to evaluate reading and writing capabilities, mechanical reasoning, ability to utilize logic, spatial awareness and sharpness of memory, must pass the physical evaluation.
